Dear Holy Redeemer Parents,

It is already time to register for next school year (2019-2020). Enclosed is your re-registration packet with forms and information necessary for you to register your children in grades K – 8 for the coming school year. **Please note the March 1st deadline to guarantee your child a space.** After that date we will begin enrolling new student applicants.

If you have a Pre-Kindergartner (4 year old) OR a Preschool (3 year old) child to enroll for next fall, please contact the school for a separate PreK/Preschool registration packet. Contact Lonney at lhauck@holyredeemerpx.org, or 503-283-5197

To Register: Please return the following forms by March 1st to ensure a space for your child/ren. After that date we cannot guarantee space.

- Family Registration Form-(include all children you are registering at Holy Redeemer in K - 8)
- Enrollment fee for each child-**non-refundable** (see below)
- Tuition Agreement Contract/Parent Commitment Form, Authorization for Automatic Withdrawal
- New students only:** copy of birth and baptismal certificate, current immunization certificate

Enrollment Fee: (non-refundable)

Kindergarten-8th grade \$150 first child; \$225 for families with two or more children in K – 8. **Please note: there is also a \$25 supply fee due for in-coming kindergarten students.**
Fees are due with the registration paperwork.

Tuition Rates/Payments for 2019-2020:

Tuition for the 2019-2020 school year will be available at a later date. The enclosed tuition sheet reflects current year's tuition. Parents can pay in full by June 20st for a 2% discount or make monthly payments. Monthly tuition payments will be on a 12 month cycle, July through June. All monthly payments will be made through automatic withdrawal from your bank account.

**The application deadline to be considered for Archdiocesan aid is March 15th.
Other families should have their applications submitted by April 15, 2019 for priority
consideration. New families should apply as soon as possible.**

The following supporting documents are required to complete the application process:

- Copy of the most recent IRS Federal Form 1040, 1040A or 1040-EZ U.S.

If applicant and co-applicant file separately, both tax returns for the same tax year are required. Do not send state tax returns.

- Copies of all the **current year W-2 Wage and Tax Statements** for both the applicant and co-applicant.

NOTE: If you are applying before you have received all the current year W-2 Wage and Tax Statements, please submit them as soon as they become available.

- **Copies of all supporting tax documents if you have business income/loss from any of the following:**

Business - send Schedule C or C-EZ and Form 4562 Depreciation and Amortization

Farm - send Schedule F and Form 4562 Depreciation and Amortization

Rental Property - send Schedule E (page 1)

S-Corporation - send Schedule E (page 2), Form 1120S (5 pages), Schedule K-1 and Form 8825

Partnership - send Schedule E (page 2), Form 1065 (5 pages), Schedule K-1 and Form 8825

Estates and Trusts - send Schedule E (page 2), Form 1041 and Schedule K-1

***IMPORTANT: If you file a tax return but do not have W-2 wages because you are self-employed, you are required to submit a copy of your current year Federal Form 1040 Tax Return.**

- **Copies of all supporting documentation for household Non-Taxable Income** such as:

Social Security Income, Welfare, Child Support, Food Stamps, Workers' Compensation, and Temporary

Assistance for Needy Families (TANF). If you do not file a tax return, you are required to provide documentation of all income received.

*All documentation received is imaged upon receipt and then destroyed.

You may login to your FACTS user account to review the status of your application. Please allow 2 weeks processing time from the date you provided the supporting documents before inquiring about receipt and/or status of the uploaded or faxed documents.

- **Holy Redeemer Parish Rate:** Requires registration in the parish, annual completion of a pledge card, and support of Holy Redeemer Parish.
- **Catholic-Other Parish Rate with Subsidy:** Must have prior authorization form signed by the Pastor of the sponsoring parish. (New parish subsidy is **\$1,075 per child for 2019 2020**)
- All families who pay monthly are required to use automatic withdrawal from their bank account.
- First payment is due in July and is **nonrefundable**.
- In order to qualify for the 2% discount, payment must be made in full on or before Thursday, **June 20, 2019, 1:00 P.M.** This discount applies to K – 8 tuition only. Families will receive a bill if they opt to make one payment.
